Minutes of Meeting of the Southeast Iowa Regional Riverboat Commission (SIRRC) October 22, 2024 Microsoft Team Meeting Link to Meeting

CALL TO ORDER/INTRODUCTIONS

COMMISSIONERS PRESENT BY MICROSOFT TEAM MEETING:

The meeting was called to order at 4:48 p.m. CST by President Justin Pieper.

COMMENTS FROM AUDIENCE: Vicky Kloepper from Daily Gate City News introduced herself and she was welcomed by Board President as well as other Commissioners of the Board.

PRIOR MEETING MINUTES:

A motion to approve the minutes of the July 23, 2024 meeting was made by Joe Steil. The motion was seconded by Steve Link. A roll call vote was held and the minutes were unanimously approved.

TREASURER'S REPORT:

A. Jason Hutcheson, Treasurer provided an update and reviewed Greater Burlington Partnership's request for reimbursement for webhosting and other internet fees applicable to SIRRC in the total amount of \$297.00. A discussion was held and Hutcheson recommended that the Board approve reimbursement of GBP in the amount of \$297.00 it had incurred for the benefit of SIRRC. Said amounts were recently paid. The charges consist of services for a three (3) year contract for webhosting and a two (2) contract for other internet services totaling the \$297.00.

- B. A general review of all outstanding expenses and revenues occurred and the financial statement is attached to the minutes as well as distributions that occurred. Questions were asked by the Board and answered satisfactorily by Hutcheson.
- C. Hutcheson lead a discussion concerning the present fund balances. He reported that presently the fund balances are reduced to \$1,000.00 monthly before distributions are made. A discussion occurred that it would be a better practice to hold \$3,000.00 and plan to increase the fund balances from \$1,000.00 per month to \$3,000.00 over a two (2) month period.

A motion was made approving A and B of the Treasurer's Report above by Bryan Bross and was seconded by Dave Schwartz. A roll call was made and A and B of the Treasurer's Report above was unanimously approved.

A second motion was made by Bryan Bross, seconded by Chuck Kempker with respect to C above and increasing fund balances from \$1,000.00 to \$3,000.00 over a two (2) month period. A roll call was made and item C of the Treasurer's report was unanimously approved.

CATFISH BEND CASINOS LLC REPORT:

Rob Higgins, General Manager for Catfish Bend Casino was present and made a report to the Commission concerning the following:

- 1. A general review of operations for quarters one (1), two (2), and three (3) of 2024 occurred. Rob reported that the first (1st) month of the fourth (4th) quarter 2024 was trending up. A discussion occurred and no action was taken by the Board.
- 2. Higgins reviewed Catfish Bend Casinos November promotions.
- 3. Higgins reviewed the current projects at the Casino including construction and remodel updates of the Casino. He provided pictures, architectural renditions, and depictions of the work completed and yet to be completed.
- 4. Higgins invited the Board to the November 21 (Thursday) Iowa Racing and Gaming Commission meeting to occur at Catfish Bend Casino. A report of the Cedar Rapids gaming license application occurred and Higgins informed the Board that was a topic on the Iowa Racing and Gaming Commission meeting for November 21, 2024.

In conclusion, Higgins was thanked by the Commission for his report. The Commission took no action.

COMMISSION'S 2025 YEAR END AUDIT

Commission contracts with CPA firms for the Commission's 2024 year end audit was discussed by President, Justin Pieper. Pieper informed the Commission that Menke & Company of West Point, Iowa and Alex T. Barr, CPA, Anderson, Larkin & Co. P.C. of Ottumwa, Iowa had presented contracts for the upcoming year. A general discussion occurred concerning the terms and conditions of the contracts and President Pieper requested a motion to consider these contracts. A motion was made by Jason Hutcheson and it was seconded by Dave Schwartz to approve the contracts for one (1) year for Menke & Company and Anderson, Larkin & Co. P.C. for services to conduct the 2024 audit. After a roll call the motion was unanimously approved.

OPEN MEETINGS MEMO:

counsel Mitchell L. Taylor, counsel for SIRRC, answered questions of President Justin Pieper concerning the open meetings memo attached to the agenda. A general discussion followed and the memo was reviewed. After discussion it was agreed that no action was requested.

OTHER BUSINESS:

President Justin Pieper requested if there was any other business that Commissioners or audience had, there being none no discussion or action followed.

ADJOURNMENT:

Bryan Bross made a motion to adjourn the meeting. The motion was seconded by Kirk Brandenberg. After a roll call the motion was unanimously approved.
